Access to the Beckwourth Riverfront Park Boat Launch Facilities will be granted to the vehicle displaying a current annual permit on the windshield, or tag holder attached to the visor or mirror in such a manner as to be easily readable to a person outside the vehicle. Owners of multiple vehicles, not exceeding three per owner, may park or launch one vehicle at a time, and may purchase and use a Change of Vehicle Ownership for the permit tag to be displayed on the vehicle in use. An additional access sticker may also be purchased with a \$5.00 fee.

This permit covers daily access to Beckwourth Riverfront Park Boat Launch Facilities including parking, boat ramp access, and day use. **This Permit does not include overnight camping.**

**DOCUMENTATION REQUIRED WITH APPLICATION**

All applicants will need to show a valid California driver's license and a copy of their vehicle registration for each vehicle listed on the permit.

Marysville residents will need to show proof of address or a change of address form from the DMV which shows a Marysville address (within City limits) for the resident fee to apply.

## INSTRUCTIONS FOR SENIOR AND DISABLED PERMITS

**“Qualified Low Income Senior” shall mean a vehicle owner who meets the criteria for a reduced fee sport fishing license as set forth in Section 7150(a)(2) of the California Fish and Game Code. Certification of income is required annually in accordance with Section 7150(b) of the California Fish and Game code by means determined by the Director of Public Works.**

Qualifier: Must own/lease vehicle(s)

Supporting Documentation: driver’s license and vehicle registration

and

Qualifier: At least sixty-five (65) years of age

Supporting Documentation: valid state driver’s license or state issued ID card

and

Qualifier: Total monthly income from all sources does not exceed the annual income levels:

Single Persons: \$ 630.00 per month

Married (combined income) \$1,167.00 per month

Supporting Documentation: Verbal statement that they did not earn anything other than Social Security benefits and Social Security Proof of Income Letter(s) or Social Security Benefit Statement(s), SSA Form 1099 for the previous year.

**“Qualified Disabled Person” shall mean a vehicle owner who meets the criteria for a no fee sport fishing license as set forth in Section 7151(a) (4) of the California Fish and Game Code. Proof of Disability is required in accordance with that code section.**

Qualifier: Must own/lease vehicle(s)

Supporting Documentation: driver’s license and vehicle registration

and

Qualifier: So severely physically disabled as to be permanently unable to move from place to place without the aid of a wheelchair, walker, forearm crutches or a comparable mobility-related device.

Supporting Documentation: Readily observable mobility-related device and doctor’s certification on CA DMV form REG 195.
