## Chapter 18.32

### CH HIGHWAY SERVICE COMMERCIAL DISTRICT

#### **Section 18.32.010 Applicability.**

This district classification shall apply along main road and highway frontages at proper intervals and locations to provide necessary services for the traveling public in developments designed for safety, convenience and fitting appearance. The following specific regulations and general rules set forth in Chapter 18.84 apply in all CH districts. (Ord. 946 § 2 (part), 1981).

#### **Section 18.32.020 Permitted uses.**

Land may be used within the CH district for general commercial uses as provided in the commercial use table, Section 18.24.030 of this code. (Ord. 946 § 2 (part), 1981).

#### **Section 18.32.030 Uses permitted with use permit.**

The following uses are permitted in the CH district subject to the issuance of a conditional use permit by the planning commission:

- (a) Those uses indicated in the commercial use table, Section 18.24.030, as requiring a use permit;
- (b) All dwellings, as defined in Section 18.04.130. (Ord. 1149 § 59, 1992; Ord. 1112 § 53, 1991; Ord. 946 § 2 (part), 1981).

#### **Section 18.32.040 Lot area.**

There are no lot area requirements in the CH district. (Ord. 946 § 2 (part), 1981).

#### **Section 18.32.050 Lot width.**

There are no lot width requirements in the CH district. (Ord. 946 § 2 (part), 1981).

#### **Section 18.32.060 Yards.**

No buildings shall be hereafter erected or constructed nor any existing building structurally altered or enlarged along the length of the building facing a street frontage in the CH district unless the following yards are provided:

- (a) Front Yard. There shall be a front yard setback of not less than five feet in the CH district except that a fifteen-foot front yard setback for a distance of twenty-five feet from an R district boundary shall be

required adjacent to an R district. The front yard shall be landscaped and shall not be used for parking or loading. Upper stories or roofs may be built over areas required for front yards; provided, that such recessed area shall have a minimum vertical clearance of twelve feet.

(b) Side Yard. There is no side yard size requirement in the CH district except that where the side line of a CH lot abuts an R district there shall be a side yard of five feet. No side yard is required adjacent to an alley. For corner lots the required side yard adjacent to the street shall be the same as the required front yard.

(c) Rear Yard. The rear yard shall be twelve feet where accessible from a street, alley or parking lot for loading purposes or five feet where rear yard is adjacent to an R district. Where a rear yard abuts an R district, a solid masonry wall not less than five feet or more than six feet shall be constructed adjacent to said line. Otherwise, there is no rear yard requirement in the CH district. The building may project over the rear yard area providing fourteen feet clear vertical distance from the ground level is maintained and the yard is not adjacent to an R district.

(d) Side or Rear Setbacks. For every building in the CH district over thirty-five feet in height above the adjacent finished grade of a contiguous residentially zoned property, three feet of setback shall be required for each additional ten feet of vertical height, or fraction thereof; provided, however, that the setback need not exceed fifteen feet and no setback shall be required adjacent to an alley. (Ord. 946 § 2 (part), 1981).

#### **Section 18.32.070 Height regulations.**

Building height limit in the CH district shall be eight stories but not to exceed eighty-five feet. (Ord. 946 § 2 (part), 1981).

#### **Section 18.32.080 Building coverage.**

There are no building coverage requirements in the CH district. (Ord. 946 § 2 (part), 1981).

#### **Section 18.32.090 Landscaping.**

Building or structures may be erected or enlarged and uses permitted provided the following minimum landscaping requirements are maintained in connection with such buildings or uses:

(a) A planter or landscaped area at least five feet wide shall be provided adjacent to all public street rights-of-way, excluding approved driveway entrances. In addition, any area within the street right-of-way, between the edge of the sidewalk and the outer edge of the right-of-way, shall be developed as a planter or landscaped area in conjunction with the required five-foot area above.

(b) Additional planters or landscaped areas shall be provided in public parking areas as specified in Chapter 18.84 of this code.

(c) Landscaped areas shall be installed and maintained as set forth in Chapter 18.86 of this code. (Ord. 1148 § 9, 1992; Ord. 1149 § 61, 1992; Ord. 946 § 2 (part), 1981).

#### **Section 18.32.100 Parking.**

Parking requirements for uses permitted in the CH district are set forth in Chapter 18.60. (Ord. 946 § 2 (part), 1981).

#### **Section 18.32.110 Outside storage.**

All outside storage areas in the CH district must be screened with solid fence no less than six feet or greater than eight feet in height, with the following exceptions: new or used automobile, boat, or trailer sales. (Ord. 974 § 8, 1982; Ord. 946 § 2 (part), 1981).

## Chapter 18.24

### COMMERCIAL USE TABLE

**Section 18.24.010 Purpose.**

The purpose of the commercial use table is to designate the uses permitted within each of the following zones:

- (a) C-1 neighborhood shopping district;
- (b) C-2 community business district;
- (c) C-3 general commercial district;
- (d) CH highway service commercial district. (Ord. 946 § 2 (part), 1981).

**Section 18.24.020 Permitted uses in commercial districts.**

With regard to the table set out in Section 18.24.030, an (X) indicates that the described use is permitted in the zone represented by the symbol appearing at the top of the column. An (O) indicates that the described use is permitted in the zone provided a use permit has been granted by the planning commission. If a use is not listed in the table, the planning commission, upon written request, shall determine whether or not such use is similar in character to a described use for the purposes of applying zone district regulations and special conditions. In instances where the use includes activities similar in character to more than one of the specific uses set forth in the commercial use table (Section 18.24.030), a use permit shall be required if any of such activities or uses would require a use permit. If a use is not similar to uses in the commercial use table, it will be allowed only with a use permit. (Ord. 1149 § 51, 1992; Ord. 1112 § 46, 1991; Ord. 1041 § 2 (part), 1986; Ord. 946 § 2 (part), 1981).
