V. FIRE SERVICES

A. FIRE CODE PERMIT PROGRAM

1. OPERATIONAL PERMITS

The following activities will require an Operational Permit to be issued by the Fire Department. The permit fee covers the initial inspection and one re-inspection. Code research and any additional inspections are \$75 per hour with a one hour minimum. Costs for said permits are shown below and are due and payable before the permit can be issued.

Rooftop heliports ~~\$75~~ \$225/annually
(Only change to Operational Permit fees)

B. FIRE CODE INSPECTION PROGRAM

1. INSPECTION SERVICES

~~Fire inspections are \$75 which includes up to one hour on the inspection plus one re-inspection. Any additional time and/or any additional re-inspections shall be billed at the rate of \$75 per hour (one hour minimum).~~

Routine fire inspections are \$75, which includes up to one hour for the inspection and one re-inspection. Any additional time and/or re-inspections will be billed at the rate of \$75 per hour (one hour minimum). All other fire prevention services, including but not limited to, plan checks, code research, and fire flow determination are \$75 per hour (one hour minimum).

For the following types of occupancies, the rates shown below will be charged for each inspection.

<i>Routine inspections (most businesses)</i>	<i>\$75</i>
<i>Schools (Plus hourly rate of \$56 for any time over four hours)</i>	<i>\$225 base inspection</i>
<i>Home Healthcare Facilities:</i>	
<i>For six or fewer residents</i>	<i>\$75</i>
<i>For seven or more residents</i>	<i>\$150</i>
<i>Child Care Facilities:</i>	
<i>For six or fewer children</i>	<i>\$75</i>
<i>For seven or more children</i>	<i>\$150</i>
<i>Motels/Hotels/Apartments:</i>	
<i>For three to nine units</i>	<i>\$75</i>
<i>For ten to sixteen units</i>	<i>\$150</i>
<i>For seventeen to thirty units</i>	<i>\$225</i>
<i>For thirty-one or more units (Plus hourly rate of \$56 for any time over four hours)</i>	<i>\$300</i>
